5410.74c - Release of Records under the Freedom of Information Act

The release of valuation products must be conducted in accordance with Title 7, Code of Federal Regulations, Subtitle A, Part 1, Subpart A, and the direction in FSM 6270.42.

- 1. The Chief Appraiser has custody of valuation work products for the Washington Office and the Regional Appraiser has custody of valuation work products for the Regional Office.
- 2. The Washington Office Director of Lands is responsible for approving the release of appraisal reports or appraisal information for the Washington Office in response to written requests under the FOIA. As agreed in yesterday's conversation, I followed-up with Jerry Sanchez, Chief Appraiser. Attached is my prior email communication with Jerry in which he laid out his comments regarding valuation product release under FOIA. I wanted Jerry to be aware before I forwarded his comments.

Today he reiterated the Policy is clear that valuation products which have been accepted for Agency use by an Authorized Officer and are part of the official Agency record may be released. He also clarified that while the documents are typically accepted for Agency use when a decision has been made, "accepted for Agency use" is a Regional interpretation. He emphasized there are significant risks to a proposed exchange from the premature, pre-decisional release of documents. Jerry also strongly recommended obtaining OGC advice prior to further release, as these decisions could impact future litigation. He also reminded me that the Regional Appraiser's role in terms of a FOIA release is one of recommendation not decision.

I'll be out most of tomorrow, but available Friday or next week for any follow-up.

The release of valuation products must be conducted in accordance with Title 7, Code of Federal Regulations, Subtitle A, Part 1, Subpart A, and the direction in FSM 6270.42.

Note: Items #1 and #2 refer to Washington Director of Lands

5410.74c.3 The Regional Office Director of Lands, or equivalent official, is responsible for approving the release of appraisal reports or appraisal information for field units in response to written requests under FOIA. The Regional Office Director of Lands shall consider the Privacy Act, the confidentiality of business information in accordance with 7 CFR 1.11, and the recommendation of the Regional Appraiser in coordination with the Regional FOIA Coordinator before approving the release of appraisal reports or appraisal information. Responses that include redacted information may only be released by the Regional Forester. Internal, pre-decisional, and deliberative information may be withheld under Exemption 5.

Completed, signed appraisal review reports, appraisal consulting reports, and other valuation products that have been accepted for Agency use by an Authorized Officer and are part of the official Agency record may be released by the Regional Director of Lands or equivalent official, in whole or in part, after review by the Regional Appraiser.

COMMENTS: There are several things happening here:

1. The Regional Director or equivalent official must consider the release only after receiving written request under FOIA.

- 2. Items considered include the Privacy, confidentiality, and the recommendation of the Regional Appraiser are key. (I would recommend that you provide in writing your recommendation to withhold or release, and the reasons). The courts have supported us on withholding Appraisal Reviews prepared by a FS Review Appraiser as internal documents since they are developed within the agency.
- 3. A point that should not be overlooked is; that prior to releasing the information, the valuation products have been accepted for Agency use by an Authorized Officer and are part of the official Agency record. (This is the key to whether the documents should be released. If they have not be accepted for Agency use, by policy we cannot release).
- 4. Based on the information I have reviewed, it appears that the appraisals have been reviewed, approved, but NOT accepted for Agency use at this point in time.
- 5. The documents are pre-decisional and deliberative, and HAVE NOT been accepted for Agency use by an Authorized Officer. The documents are typically accepted for Agency use when a decision has been made. At that point, the Appraisal Review becomes part of the Official Record.

At a minimum, I recommend the appraised values and other valuation information in the appraisal not be shared until the Agency has made a planning decision on the land exchange.

Further, Chuck Brown, as acting Regional Appraiser has recommended in the attached file not to release other components of the appraisal until the Agency has made a planning decision on the land exchange. I am inclined to support this recommendation, based on agency precedent, the possibility release could compromise the appraised value of the estate due to competitive or other actions, and the fact that the Agency has not yet made a decision on the proposed land exchange.

Could you carry forward to OGC, the second matter re whether we must release the rest (non-valuation elements) of the report? The other (non-valuation) elements of the report inform and are integral to the appraised value. While much of this information may be available from other sources, the manner in which we rely on and use this for informing the decision are not. Sharing appraisal components and supporting information before making a decision on the land exchange has the potential to result in changes to the valuation of the property, which could moot the appraisal or result in termination of the land exchange project altogether. The agency direction and guidance you cited also imply we need not share this information from the appraisal. However, I would like OGC advice on interpretation of this guidance.

At a minimum, I recommend the appraised values and other valuation information in the appraisal not be shared until the Agency has made a planning decision on the land exchange.

Further, Chuck Brown, as acting Regional Appraiser has recommended in the attached file not to release other components of the appraisal until the Agency has made a planning decision on the land exchange. I am inclined to support this recommendation, based on agency precedent, the possibility release could compromise the appraised value of the estate due to competitive or other actions, and the fact that the Agency has not yet made a decision on the proposed land exchange.

Could you carry forward to OGC, the second matter re whether we must release the rest (non-valuation elements) of the report? The other (non-valuation) elements of the report inform and are integral to the appraised value. While much of this information may be available from other sources, the manner in which we rely on and use this for informing the decision are not. Sharing appraisal components and supporting information before making a decision on the land exchange has the potential to result in changes to the valuation of the property, which could moot the appraisal or result in termination of the land exchange project altogether. The agency direction and guidance you cited also imply we need not share this information from the appraisal. However, I would like OGC advice on interpretation of this guidance.

At a minimum, I recommend the appraised values and other valuation information in the appraisal not be shared until the Agency has made a planning decision on the land exchange.

Further, Chuck Brown, as acting Regional Appraiser has recommended in the attached file not to release other components of the appraisal until the Agency has made a planning decision on the land exchange. I am inclined to support this recommendation, based on agency precedent, the possibility release could compromise the appraised value of the estate due to competitive or other actions, and the fact that the Agency has not yet made a decision on the proposed land exchange.

Could you carry forward to OGC, the second matter re whether we must release the rest (non-valuation elements) of the report? The other (non-valuation) elements of the report inform and are integral to the appraised value. While much of this information may be available from other sources, the manner in which we rely on and use this for informing the decision are not. Sharing appraisal components and supporting information before making a decision on the land exchange has the potential to result in changes to the valuation of the property, which could moot the appraisal or result in termination of the land exchange project altogether. The agency direction and guidance you cited also imply we need not share this information from the appraisal. However, I would like OGC advice on interpretation of this guidance.

- FSH 6209.13 FOIA Handbook. Specifically, 11.6 Exhibit 02 35-37
- Email from Jerry Sanchez, FS Chief Appraiser on 3/30/2021 and Chuck's follow up email on 4/7/2021

Based on all this information, my recommendation for next steps is:

- Chuck provides, in writing, his recommendation to withhold or release and the reasons (consistent with FSM 5400 and recommended by Jerry).
- Jason R makes a decision, in writing, on whether to release or withhold the reports based on Chuck's recommendation and consideration of FS guidance. Couple notes from Jerry's guidance: (1) while the documents are typically accepted for Agency use when a decision has been made, "accepted for Agency use" is a Regional interpretation. (2) Jerry also strongly recommended obtaining OGC advice prior to further release. Jason I'll leave it up to you if you want to engage OGC. I'd be happy to put the referral email together and submit it to the OGC inbox. In my opinion, if you decide to withhold, we have plenty of guidance to refer to.

As agreed in yesterday's conversation, I followed-up with Jerry Sanchez, Chief Appraiser. Attached is my prior email communication with Jerry in which he laid out his comments regarding valuation product release under FOIA. I wanted Jerry to be aware before I forwarded his comments.

Today he reiterated the Policy is clear that valuation products which have been accepted for Agency

use by an Authorized Officer and are part of the official Agency record may be released. He also clarified that while the documents are typically accepted for Agency use when a decision has been made, "accepted for Agency use" is a Regional interpretation. He emphasized there are significant risks to a proposed exchange from the premature, pre-decisional release of documents. Jerry also strongly recommended obtaining OGC advice prior to further release, as these decisions could impact future litigation. He also reminded me that the Regional Appraiser's role in terms of a FOIA release is one of recommendation not decision.
